REAL MIRACLES FC CLUB VRS YOUNG DESERT WARRIORS FC

**PROTEST IN RESPECT OF 2022/ 2023 ADONAI ESTATE VOLTA
REGIONAL DIVISION TWO LEAGUE MATCH PLAYED AT YADZO
STADIUM.**

PROCEEDINGS

In accordance with Article 56 of the GFA Statutes (2019) and 35(9) of the Regional Football Association (RFAS) Leagues Regulations, this Disciplinary Committee(herein after referred to as **“The Committee”**) considered the deposition from Real Miracles F/C Club (herein referred to as **“The Petitioner”**) with supporting attachments, and match reports from match officials.

SUMMARY OF FACTS

STATEMENT OF CASE OF REAL MIRACLES FC

The Petitioner lodged a protest against Young Desert FC (herein after referred to **“The Respondents”**) for failing to honour a league match played against the Petitioner without a just cause during the Adonai Estate Volta Regional Division Two League match played on 12th February 2022 at Yadzo contrary to article 33(1)(f) of the GFA Regional Football Association (RFAs) League Regulations.

DEFENSE OF YOUNG DESERT FC

The Respondent did not file any response to the case.


FINDINGS OF THE COMMITTEE AND GROUNDS OF DECISION

The Committee at its sittings makes the following findings

1. That protest was lodged in accordance with Article 35(1)(3) of the Regional Football Associations (RFAs) League Regulations
2. That the protest was duly served on The Respondent in accordance with Article 35(4) of The Regional Football Associations (RFAs) League Regulations
3. That Young Desert FC failed to honour match between the Petitioner and Respondent scheduled on 12th February 2022 without just cause.

DECISION

1. It is the decision of The Committee that the Petitioners' case is hereby upheld and that 3 points and 3 goals shall be awarded to the Petitioner, in accordance with Article 33(3) of the GFA (RFAs) Leagues Regulations.
2. The Respondent is hereby fined GHC500.00 of which 50% of which shall be paid to the Petitioner in accordance to Article 33(5)(b) of the GFA Regional Football Association (RFAs) League Regulations.
