**KRACHI ELEVEN BROTHERS FC VS KPANDO ELEVEN WONDERS FC**

**PROTEST IN RESPECT OF 2025/2026 VOLTA DIVISION TWO LEAGUE MATCH  
PLAYED AT GYENGYEN PARK**

---

**PROCEEDINGS**

In accordance with Article 56 of the GFA Statutes (2019) and 35(9) of the Regional Football Associations Leagues Regulations, this Disciplinary Committee (hereinafter referred to as “**The Committee**”) considered the deposition from Krachi Eleven Brothers FC (herein after referred to as “**The Petitioner**”) and Kpando Eleven Wonders FC (herein after referred to as “**The Respondent**”) with supporting attachments, and match reports from match officials.

**SUMMARY OF FACTS**

**STATEMENT OF CASE OF KRACHI ELEVEN BROTHERS FC**

The Petitioner lodged a protest against Kpando Eleven Wonders FC for fielding unqualified player Awal Kasim and refusing to use CMS as directed by the RFA, during the Volta Division Two League Match Day 2 played on 22<sup>nd</sup> November, 2025 at Gyengyen Park, contrary to Article 28(1) (d), 28(2)(a), 28(2)(c) and 33(1)(e) of the GFA Regional Football Associations Leagues Regulations. The Petitioner in making their case stated the following that:

1. The Respondent fielded unqualified player Awal Kasim who is also registered in the FIFA Connect System of Destiny Stars SC with FIFA ID 1HIBMI4, member ID GHA 165738M and 01/01/2007 as date of birth.
2. That the Respondent failed to produce player Awal Kasim for inspection knowing that the said player was not qualified to feature in the said match.

3. That the Respondent failed to use the CMS as directed by RFA for 2025/2026 league season

The Petitioner further seeks relief that the match be declared null and void and that 3 points and 3 goals be awarded to The Petitioner.

The Petitioner attached the following documents in support of their case;

1. The team sheet of the Respondent including the said player Awal Kasim without a jersey number.
2. Team Picture without Awal Kasim during inspection.
3. A picture of the match report from the referee.

#### **STATEMENT OF DEFENSE KPANDO ELEVEN WONDERS FC.**

The Respondent in response to the case stated the following that:

1. The Petitioner failed to produce any evidence that suggest the said player Awal Kasim was not registered by the Respondent which amount to multiple registration.
2. The said player Awal Kasim is a transferred player from NANIA FC and that the said transfer was done on 25<sup>th</sup> January, 2024.
3. There was a challenge to the club's CMS System due to network so the club resort to the team sheet and players approved in the FIFA Connect System of the Respondent were enrolled

#### **FINDINGS OF THE COMMITTEE AND GROUNDS OF DECISION**

The Committee at its sittings makes the following findings;

1. That protest was lodged in accordance with Article 35(1)(3) of the Regional Football Associations Leagues Regulations.
2. That the protest was duly served on The Respondent in accordance with Article 35(4) of the GFA Regional Football Associations Leagues Regulations
3. This Committee confirmed from the IT Officer of the RFA that the said player is found in the FIFA Connect System of Destiny Stars SC with FIFA ID 1HIBMI4 and 01/01/2007 as date of birth with the player's registration not renewed for the 2025/2026 League Season.
4. This Committee confirmed from the IT Officer of the RFA that the said player is found in the FIFA Connect System of Kpando Eleven Wonders FC with FIFA ID 1EXE5B7 and 01/01/1998

as date of birth with the player's registration renewed for the 2025/2026 League Season by the Respondent.

5. This Committee considered the situation and conclude that it is a case of double registration and that the player and Destiny Stars SC are the guilty party in this case and are liable to the consequential effect of Article 28(2)(a)(b)(c) of the GFA Regional Football Leagues Regulations.

6. The player in this case is the sole guilty party and therefore the result of the said match shall stand in accordance with Article 28(2)(b) of the GFA Regional Football Leagues Regulations.

7. The match ended 1-1


## **DECISION**

1. It is the decision of The Committee that; the Petitioner's case is hereby dismissed and the result of the said match in this case shall stand.

2. There shall be no cost effect on either parties.

3. The RFA is by this ruling directed to ensure a case of double registration by Awal Kasim is reported to the Ghana Football Association for the registration of the said player to be regularized.

4. The said player, Awal Kasim is hereby banned from taking part in any GFA/RFA organised programme for 1 year in accordance with Article 28(2)(c) of the GFA Regional Football Associations Leagues Regulations, effective from the date of receipt of this ruling.
