KPASSA REAL MIRACLE FC VRS OTI UNITED FC

**PROTEST IN RESPECT OF 2025/2026 VOLTA REGIONAL DIVISION TWO
LEAGUE MATCH PLAYED AT BODADA PARK.**

PROCEEDINGS

In accordance with Article 56 of the GFA Statutes (2019) and 35(9) of the Regional Football Association Leagues Regulations, this Disciplinary Committee (hereinafter referred to as "**The Committee**") considered the deposition from Kpassa Real Miracle Football Club (hereinafter referred to as "**The Petitioner**") with supporting attachments, and match reports from match officials.

SUMMARY OF FACT

STATEMENT OF CASE OF KPASSA REAL MIRACLE FC

The Petitioner lodged a protest against Oti United FC for fielding unqualified players and team official during the Volta Regional Division Two League match Day One played on 20th December, 2025 at BODADA Park, contrary to article 28(2)(a),33(1)(e) of the GFA Regional Football Associations Leagues Regulations.

The Petitioner's case is that, The Respondent fielded unqualified players and team officials by names Francis Kaidabi (1) Felix Samanuhya (15) Isaiah Atugba (5) Isaac Addeg (14) Thomas Agbavor (2) Christian Dzator (10) Jeff Agbenyaga (7) Albert Mensah (16) Nurudeen Ibrahim, Richmond Amponsah, Edmond Ampadu, Promise Nyarko, Bright Appew, Edward Ntem, Gabriel Ayamesu, Richard Akoto, Nicholas Gyambi, Hamza Gabriel(coach) Francis Asiedu and Kingsley

Amponsah Ansah, who were not registered in the FIFA Connect System of the Respondent and therefore, not eligible to play for the Respondent in the said match in this case.

The Petitioners pray this Committee to invoke the following articles 33(1)(e) against the Respondent.

The Petitioner seeks relief that said match be declared null and void and that 3 points and 3 goals be awarded to The Petitioner.

The Petitioner prays this Committee to confirm their claim from the reports of the Match Commissioner and the Referee appointed for the said match and also attached the Team sheet of the Respondent of the case and refer the Disciplinary Committee to match commissioner's report.

The Petitioner prays this Committee to punish the Respondent in accordance with article 33(5) of the GFA Regional Football Associations League Regulations.

DEFENSE OF OTI UNITED FC

The Respondent did not file Statement of Defense to the case.

FINDINGS OF THE COMMITTEE AND GROUNDS OF DECISION

The Committee at its sittings makes the following findings;

1. That protest was lodged in accordance with Article 35(1)(3) of the GFA Regional Football Associations Leagues Regulations.
2. That the protest was duly served on The Respondent in accordance with Article 35(4) of The GFA Regional Football Associations Leagues Regulations.
3. This Committee confirmed from the IT Officer of the RFA that the said players Francis Kaidabi (1) Felix Samanuhya (15) Isaiah Atugba (5) Isaac Addeg (14) Thomas Agbavor (2) Christian Dzator (10) Jeff Agbenyaga (7) Albert Mensah (16) Nurudeen Ibrahim, Richmond Amponsah, Edmond Amzadu, Promise Nyarko, Bright Appew, Edward Ntem, Gabriel Ayamesu, Richard Akoto, Nicholas Gyambi, Francis Asiedu and Kingsley Amponsah were not registered in the FIFA Connect System of the Respondent, and therefore not eligible to play the said match in this case.
4. That Hamza Gabriel (coach) was not duly registered therefore not qualified to sit on the bench and act as a team official for the Respondent in the said match.

DECISION

It is the decision of The Committee that; the Petitioners' case is hereby upheld and that 3 points and 3 goals shall be awarded to the Petitioner in accordance with Article 33(3) of the GFA Regional Football Associations Leagues Regulations.


2. The Respondent shall suffer 3 points deductions from accumulated points of the club in accordance with Article 33(5)(a) of the GFA Regional Football Associations Leagues Regulations.

3. The Respondent is hereby fined GHC 500.00 of which 50% shall be paid to the Petitioner in accordance to Article 33(5)(b) of the GFA Regional Football Associations Leagues Regulations.

4. The Respondent shall pay the fine in decision Three (3) above within ten (10) days in accordance with Article 37(8) of the GFA Regional Football Associations Leagues Regulations.

5. The Respondent shall be liable to the consequential effect of Article 37(1)(b) and 37 (8)(c) of the GFA Regional Football Associations Leagues Regulations if the club fails to pay the fine imposed on the club in Three (3) above within the period specified in decision Four (4) above.

6. The said players Francis Kaidabi (1) Felix Samanuhyia (15) Isaiah Atugba (5) Isaac Addeg (14) Thomas Agbavor (2) Christian Dzator (10) Jeff Agbenyaga (7) Albert Mensah (16) Nurudeen Ibrahim, Richmond Ampontah, Edmond Amzadu, Promise Nyarko, Bright Appew, Edward Ntem, Gabriel Ayamesu, Richard Akoto, Nicholas Gyambi, Hamza Gabriel(coach) Francis Asiedu and Kingsley Ampontah shall be suspended from participating in matches and competition organised by the GFA until such time that their registration is regularized.
