COUNT 1

Statement of Offence

Akatsi Kickers FC Is hereby charged with breach of Article 12 of the GFA Disciplinary Code,2019

Particulars of the Offence

Akatsi Kickers FC on Saturday 13th December, 2025 during the Volta Regional Division Two League Match scheduled to be played at Atatsico park between your club and Lucky Stars FC. you did breach provisions of the GF A Disciplinary Code,2019. for misconduct. An action which amounts to unsporting behaviour and misconduct.

COUNT 2

Akatsi Kickers FC is hereby charged with breach of Article 34(1)(a) of the GFA/Regional Football Association Leagues Regulations

Particulars of the Offence

Akatsi Kickers FC Akatsi Kickers FC on Saturday 13th December, 2025 during the Volta

Regional Division Two League Match scheduled to be played between your club and Lucky Stars FC you did breach provisions of Article 34(1)(a) of the GFA/Regional Football Association Leagues Regulations.

Your Club failed to provide uniform security which led to the official call of the said match by the match official. An action which amounts to unsporting behaviour and misconduct.

Should you choose Defence Options 3(Personal Hearing) in your Statement of Defence the Disciplinary Committee shall communicate to you the date and time to appear before the Disciplinary Committee to answer to the charge(s), failing which the Disciplinary Committee shall proceed to adjudicate the case in your absence.
