CHARGE(S)

COUNT 1

Statement of Offence

KETA FC is hereby charged for the breach of Article 34(6)(d) of the GFA Regional Football Associations Leagues Regulations and Article 11 of the GFA Disciplinary Code in respect of unguided and disparaging comments concerning the RFA and the Disciplinary Committee of the RFA.

Particulars of the Offence

Keta FC on Thursday 28th May, 2026 your club made unproven and disparaging comments in your press release on your social media page (Facebook) following a previous ruling in the Case No VRFA/DC/031/26, Yingor FC vs Keta FC suggesting bias within the RFA /Disciplinary Committee which brings the game into disrepute.

PUNISHMENT

In your Statement of Defence you must choose one of the following options

1. I am pleading **GUILTY** to the charge(s) and I hereby submit Written Statement for mitigation and supporting Evidence to be considered by the Disciplinary Committee

2. I am pleading **NOT GUILTY** to the charge(s) and I WAVE MY RIGHT TO PERSONAL HEARING, but I hereby submit Written Statement of Defence and supporting Evidence to be considered by Disciplinary Committee.

3. I am pleading **NOT GUILTY** to the charge(s) and I REQUEST PERSONAL HEARING to defend myself against the charge (s).

NOTES

Please note that should the Disciplinary Committee be successful in proving your breach of the relevant Code(s) or Regulation(s), the Disciplinary Committee shall impose the maximum sanction(s) as set out therein.

REPLY DATE

Kindly, submit your written Statement of Defence to the charge(s) **by close of work, Thursday 4th June, 2026 by 5:00pm** through email address of the RFA voltafadc@gmail.com failing which the Disciplinary Committee shall proceed to adjudicate the case without your Statement of Defence.

PERSONAL HEARING IF ANY

Should you choose Defence Options 3(Personal Hearing) in your Statement of Defence, the Disciplinary Committee shall communicate to you the date and time to appear before the Disciplinary Committee to answer to the charge(s), failing which the Disciplinary Committee shall proceed to adjudicate the case in your absence.
